This Agreement signed on **02/01/2020** between **Pioneer Elabs Limited** having its Regd. Office at Plot no. 16, Software Units Layout, Madhapur (Hitech-city), Hyderabad-500081, and **Vidya Jyothi Institute of Technology**, having its registered office at Aziz Nagar Gate, C. B. Post, Hyderabad - 75, Represented by **PRINCIPAL** and is here in after called as Subscriber.

Whereas **Pioneer Elabs Limited** is engaged in providing INTERNET SERVICES by virtue of its valid license issued by the Ministry of Communications, Department of Telecommunications, Government of India.

Where as subscriber is engaged as **Vidya Jyothi Institute of Technology**, and requested **Pioneer Elabs Limited** to provide Internet Connectivity on a point to point basis i.e..from **Pioneer Elabs Limited** /POP to the premises of **Vidya Jyothi Institute of Technology**. The Parties now being desirous of reducing this agreement in writing have entered into this agreement with the manner herein after appearing.


1. **Vidya Jyothi Institute of Technology**, shall pay an amount of **Rs.6,00,000/- (Six Lakh Rupees Only)** yearly towards the Charges for **100 Mbps Dedicated Internet Leased line** which are to be borne by the Subscriber and are Excluding tax in the above pricing and have to be paid as per Govt. of India regulations. The Billing has been done from the LOC date.
2. Subscriber shall use the Internet connectivity at the premises specified at the time of installation to **Pioneer Elabs Limited**, however in case of any possible shift / change of address, Subscriber shall intimate the same to **Pioneer Elabs Limited** in writing wherein **Pioneer Elabs Limited** shall provide Internet Connectivity to the said premises after Inspection of the same.
3. **Pioneer Elabs Limited** shall ensure immediate response on **Vidya Jyothi Institute of Technology** queries but will not be responsible for Subscriber's internal LAN Connectivity issues.
4. In the event of the **Vidya Jyothi Institute of Technology** with drawing from the proposed purchase of **Pioneer Elabs Limited** Services for various reasons inclusive of cancellation of projects etc., any advance paid will be forfeited in total without written notice under any circumstances.
5. If required the upgradation and downgradation of existing bandwidth will be permitted to change during the contract period but the cost per Mbps remains the same, on the request sent to the service provider through subscriber's official email or official written communication.

AND

M/s. Vidya Jyothi Institute of Technology having its registered office at Aziz Nagar Gate, C. B. Post, Hyderabad – 75. Represented by **Dr.A Padmaja** and is here in after called as Subscriber.

Whereas **GTPL Broadband Pvt Ltd** is engaged in providing INTERNET SERVICES by virtue of its valid license issued by the Ministry of Communications, Department of Telecommunications, Government of India

Where as Subscriber is engaged as **M/s. Vidya Jyothi Institute of Technology** and requested GTPL Broadband Pvt Ltd to provide Internet Connectivity on a point to point basis i.e., from GTPL Broadband Pvt Ltd to the premises of **M/s. Vidya Jyothi Institute of Technology**. The Parties now being desirous of reducing this agreement in writing have entered into this agreement with the manner hereinafter appearing.

1. **M/s. Vidya Jyothi Institute of Technology** shall pay an amount of **Rs.2,82,808/- (Two lakhs eighty two thousands eight hundred eight Rupees Only)** yearly towards the Charges for **100 Mbps Dedicated Internet Leased line** are to be borne by the Subscriber and are Excluding tax in the above pricing and have to be paid as per Govt. of India regulations and **M/s. Vidya Jyothi Institute of Technology** shall make payments on quarterly basis. The Billing has been done from the LOC date.
2. GTPL Broadband Pvt Ltd shall ensure 99.9% up time. Subscriber assumes the responsibility of going for bandwidth owing to the criticality of his business operations.
3. Subscriber shall use the Internet connectivity at the premises specified at the time of installation to GTPL Broadband Pvt Ltd, however in case of any possible shift / change of address, Subscriber shall intimate the same to GTPL Broadband Pvt Ltd in writing wherein GTPL Broadband Pvt Ltd shall provide Internet Connectivity to the said premises after Inspection of the same.


6. As Per Clause 1.12.3 Schedule C part ii of ISP License agreement, Telephony on Internet is not permitted.
