Four B.Tech., I year students of AI(Artificial Intelligence) branch gave a complaint on 12.02.2020 that some senior students from Mechanical Engineering (B.Tech., II year) department lead by Mr. M. Srikar Reddy (Roll No: 18911A0323) came to their hostel room and threatened them to give the phone numbers of girl students of their class. In their complaint it was also mentioned that if numbers are not given they will not hesitate even to manhandle them. Mr. M. Srikar Reddy was in an inebriated condition at that time. In this entire incident, the roles played by Mr. Varun, Mechanical Engineering (B.Tech., II year) and Mr. Rajiv ECE (B.Tech., II year) are also to be investigated as their behavior on 12.02.2020 is arrogant and suspicious. Further, after realizing that it's not easy to get the telephone numbers, they have even locked their rooms. In view of these developments, the B.Tech., I year (AI) students were afraid of going to their hostel as something may happen again.

Meanwhile, the HoD of H&S in a letter requested to look into an issue which is connected with the above mentioned ragging problem. The head H&S is of the opinion that the behavior of a group of B.Tech., I year students who are creating disciplinary problems in the college, is also to be investigated from very close angles.

In view of this, to look into ragging problems created by B.Tech., II year students and the unusual & erratic behavior of some B.Tech I year students, an enquiry committee with the following members has been appointed,



ENQUIRY REPORT

14/02/2020

SUB: Enquiry report – Complaint lodged by First year students
REF: VJIT/Dir.ofc/12/2019-20, dated 13-02-2020

As per the order cited in the reference above, the Committee carried out the enquiry proceedings on 13th and 14th February 2020 and listened to the submissions of Mr. KVS Chaitanya(19911A3527), T.Kamal Kumar(19911A3551), S.Satwik(19911A3549), D.Rohan(19911A3512) of first year AI Branch and enquired M.Srikar Reddy(18911A0323), K.Varun Kumar(18911A0365), S. Rajiv Manikanta(18911A04B0), L. Surya Prakash(19911A05E9), K.Sairam(19911A0236), A. Murali Mohan(19911A05C1), S Harshith(19911A0448).

Findings of the Committee

- The committee investigated the students connected with the issue.
- **M.Srikar Reddy** accepted that he was in inebriated state when he went to hostel on **11th February 2020** to threaten the first year AI students (mentioned above) intentionally (Audio Proof is available).
- **M.Srikar Reddy** accepted that three months back he demanded the same set of students to share the contact numbers of girl students of their branch and locked their hostel room and left when they refused to do so.
- In this regard it is to mention that **Srikar Reddy** does not reside in the same hostel. He resides with his parents at Suncity.
- **Rajeev** witnessing the situation didn't intervene to restrict **Srikar Reddy's** rude behaviour
- **K. Varun Kumar** agreed that he has warned the same set of Ist year students on 12th February 2020 to close the issue by conveying sorry to **Srikar Reddy**, failing which they may be given the same treatment like **Surya** and **Sairam** who were manhandled by him the previous day in the same hostel premises.
- **Surya** and **Sriram** came to hostel along with few outsiders on **10th February 2020** in a drunken state and asked **Harshith** to come out of the Hostel and started abusing him in a filthy language
- Meanwhile **Varun** along with few hostel mates reached the place and tried to pacify **Surya** and **Sriram** but their efforts went in vain and in turn **surya** and **Sriram** started abusing **varun** and his hostel mates and tried to attack them
- Consequently **Varun** with his hostel mates manhandled **Surya** and **Sairam** to their core and informed the same to the parents of **Surya** and **Sairam**.
- **Surya** and **Sriram** were instigated against **Harshith** by **Murali Mohan** few days ago as **Harshith** was interfering in context to his friendship with a girl student which was admitted by **Murali** and **Harshith**


Findings of the Committee


- The committee investigated the staff and students travelled on the bus and they confirmed the ragging.

- **Jeevan Reddy** was not directly involved in ragging but strongly supported Rahul Reddy


Action Recommended:-

1. It is recommended to punish **Mr.Rahul Reddy**(16911A04F9) as per the college norms to see that such incidents don't get repeat.
2. **Mr. A. Vishal**(15911A0358) should be punished for his support to Rahul Reddy and also allowing his friend from other college to board the bus.
3. **Mr. N.Jeeven Reddy**(16911A0539) should also be punished for his support to Rahul Reddy and keeping quiet when ragging is taking place.
4. It is advised to make first year students to sit in front seats in their respective buses.
5. Ensure that Teaching or non-teaching staff should be available up to the end/start point of that bus route.
6. Restrict the unauthorized students travelling in the bus.
7. The transport in-charge must maintain updated Student details and the same copy should also be available with Bus staff-incharge
8. The students should not be allowed either to get down or board the bus except the designated stops.
9. The students must wear their ID cards while travelling in the college bus.


These steps will go a long way in preventing such occurrences in the future.





Grievances Redressal Policy

To address the grievances of the students, parents and others, as per All India Council for Technical Education (AICTE) regulations, 2012 under clause 1 of section 23 of the AICTE Act, 1987 regarding the establishment of Mechanism for Grievance Redressal in Technical Institutions, Grievance Redressal Committee (GRC) is formed in the college. The objective of GRC is to develop a harmonious educational environment in the institute.

Composition and Tenure of the Committee

- The committee shall comprise of a Chairperson, Convener and three other senior teaching faculty members.
- Principal of the college shall be the chairperson.
- Members of the committee shall be nominated by the chairperson for tenure of two years.
- Out of Four (including convener), one member shall be female and other from SC/ST/OBC category.
- A representative from among the students of the college to be nominated by the chairperson as special invitee.

Scope of the grievances


Grievances may be related to any of the following matters:

- Academic Matters – Issues related to assessment, attendance, marks, and other examination related matters etc.
- Financial Matter – Issues related to charging of fees, scholarships and payments
- Administration Matters – Issues related to infrastructure, basic amenities, sanitation, transport or victimization
- Harassment and Ragging by colleague students or teachers etc.

Grievance receiving mechanisms

Anyone with a genuine grievance may lodge their complaint to GRC along with necessary documents, if any. The grievance shall be reported by using any of the following modes:

- Report submission in person by approaching the chairman of the Committee

Grievance redressal mechanism

- After the receipt of the application from the aggrieved, the chairman of GRC shall fix the date, time and venue of the meeting after having a discussion with the members.
- The meeting shall be scheduled within Five days of receipt of the application.
- All relevant papers shall be circulated as hard / soft copy to all the members on or before the date of the meeting.
- After fixing of the date of the meeting, a hard copy of the notice must be sent to the applicant to be present in the meeting and convey his or her grievances before the Committee and the acknowledgement of receipt would be placed on record.
- The Committee members are expected to deliberate upon the case, the grievance of the applicant and the rules laid down by the institute. The brief facts, evidences and final recommendations by the Committee members shall be recorded in the format of minutes of the meeting.
- The minutes shall be circulated to all the members of the Grievance Committee for their signatures.
- The decision of the Grievance Committee shall be communicated in writing to the applicant at the earliest.

Appeal

- The applicant shall have the right to file an appeal to the Chairman within 15 days from the date of the written communication of recommendations of the committee.
- The applicant shall send written communication to the college conveying his desire to file an appeal to the Chairman. The college shall place the appeal along with all relevant material before the Ombudsperson and inform the applicant accordingly. The Chairman shall within a reasonable time decide the appeal. Final decision would be communicated to the applicant by the college.
