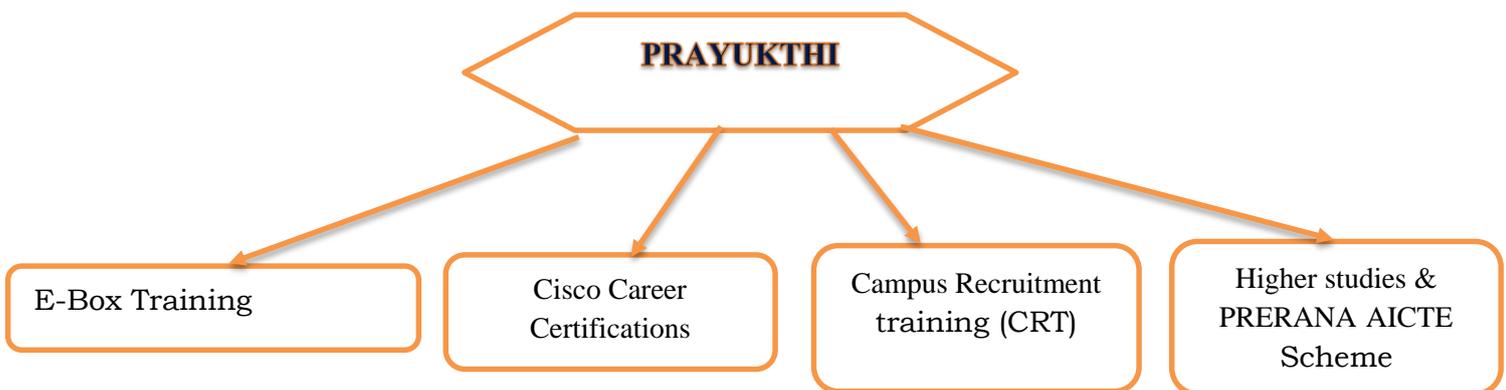


Fig.1: Different wings of PRAYUKTHI- VJIT.

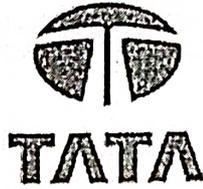

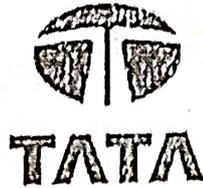
