Minutes of the 17th Academic Council meeting held on 23rd September 2022

The Chairman of the Academic Council, Dr E. Saibaba Reddy, welcomed the members and introduced Dr Aruna Kumari , New Nominee from JNTUH and also other new members added to Academic Council from VJIT.

Dr A. Padmaja, Vice-Chairperson, started the proceedings by placing the major achievements of the college before the council.

- 1. NIRF in Engineering Category 200 Rank, 2022
- 2. Atal Ranking of Institutions on Innovations Achievements (ARIIA), 2021 Excellent Category (Rank 6-101)
- 3. UGC granted Autonomy (2015-16 to 2020-21) & Extension of Autonomy given in the year 2021
- 4. Five Eligible B. Tech Programs are accredited by NBA under TIER-1 and Civil Engineering Department accredited under Tier-2
- 5. Accredited by NAAC A+ Grade with CGPA 3.33
- 6. JNTUH Recognized Research Centers: ECE and EEE Departments in addition to the existing Research Centers in CSE and Mechanical.

The members of the Academic Council noted the achievements.

Item 1: To approve the minutes of 14th, 15th and 16th Academic Council Meetings

Dr Padmaja put forward the minutes of the 14th, 15th and 16th academic council meetings.

Approval of minutes of 14th Academic Council Meeting held on 4th September 2021

- Syllabi of B.Tech Courses applicable to the students admitted in Academic Year 2020-21 onwards.
- To approve question paper patterns for B.Tech courses in view of Covid conditions.
- To review the Final Year Marks of B.Tech, M.Tech and MBA

The above minutes were approved by the members.



Item 2: To ratify the Course Structure and Board of Studies minutes of various departments of B.Tech under R21 Academic regulations and the Course Structure and Board of Studies minutes of MBA Program under R22 Academic regulation.

Dr Padmaja appraised the committee about the course structure for B.Tech. under R21 and MBA under R22 Academic Regulations.

Annexure - 1

Dr Asha Rani, JNTUH nominee, enquired whether the distribution of credits was uniform across programs in the R21 course structure. Principal informed that the total credits are 160 and she also clarified that credits distribution is uniform across programs.

Dr Asha Rani suggested that more professional courses may be introduced as per industry need. Dr MV Krishnamurthy suggested that the electives offered by various departments can be grouped into different streams/tracks to allow B.Tech students specialize in a particular area. He ascertained this would result in more cohesive students with the required industry expertise.

Dr Asha Rani observed that the course structures of various programs, have 06 theory and 02 laboratory courses in some semesters. She suggested that more practice-oriented learning be introduced, preferably 5 Theory and 3 Laboratory courses, as suggested by AICTE.

The chairman, Dr Sai Baba Reddy, informed all the members of the Council that the Course structure followed under academic regulation R22 is premeditated to be more practice oriented.

Dr Asha Rani inquired regarding the distribution percentages of courses belonging to the various categories e.g. HS, BS, ES etc. as per AICTE.

Principal brought to the notice of the council members that we are following the course distribution as suggested by AICTE.

She also communicated that the fast-track option given to students, has improved students' placements and internships.

With the above discussion the Members ratified the points raised in the Item

Item No 3: To ratify the amendment made to academic regulation R21.

Dr A Padmaja appraised the committee regarding amendments made in academic regulation R21.

The distribution of marks is 70 in Semester end examinations (SEE) and 30 marks for continuous internal evaluation (CIE) for a theory/practical/design/drawing course. To pass a course, as per Academic regulations R21 under section 7.1, a student needs to secure 35% of external marks and overall pass percentage of 40%. In this context 35% of 70, works out to

be 24.5 marks. The 15th meeting of the Academic Council of the college has approved to consider the minimum requirements as 24 marks (rounding off to lower side).

However, during the result processing committee meeting, JNTUH nominee informed to follow as per JNTUH norms i.e., 24.5 marks to be rounded off to 25 marks as followed by the University and all other Autonomous colleges.

The council approved the amendment and section 7.1 under Academic regulation R21 is henceforth read as

"A student shall be deemed to have satisfied the academic requirements an earned the credits allotted in each theory/ practical/ design/ drawing subject if student secures not less than 35% (25 marks out of 70 marks) in the Semester end examination, and a minimum of 40% (40 marks out of 100 marks) in the total of the CIE and SEE (Semester End Examination) taken to the in terms of letter grades, this implies securing C grade or above in that subject/ Course".

Dr Asha Rani enquired about the viability of the financial expenditure as against the income. Principal informed the council the exam finances are well balanced.

Dr Krishnamurthy and Dr Utla Balaji suggested a periodic review of these remunerations keeping inflation, CPI, etc in view. They said although this is more of service by the academic community, remuneration paid needs to be respectable.

The Academic Council members ratified the Examination remuneration being implemented.

Dr Asha Rani enquired about the laboratories for the proposed Minor and Honour degree programs. The Heads of Departments informed that establishing necessary laboratories is in progress.

Dr Asha Rani informed that the faculty offering courses for the minor degree should be paid extra remuneration. Director informed that if faculty has a load over and above stipulated workload as per AICTE, an additional amount will be paid.

Dr Asha Rani advised to specify prerequisites for all the courses introduced under the B.Tech. with Minor and Honours degree. She also suggested that hands-on experience be given through internships for the Honour degree.



On the Minors offered by various departments Dr Krishnamurthy suggested that the courses need to be carefully selected as they are for students of other departments. Unless the students complete the required prerequisite courses, they should not be offered advanced courses. He also observed that courses offered under CSE minor are not basic courses and suggested to make appropriate changes to include courses like Data Structures, Design & Analysis of Algorithms, Operating systems, Databases and Introduction to Al. He also felt as the programs are highly interdisciplinary, faculty must be drawn from across departments for teaching. Dr Sreeram Reddy, HoD of ME, informed the council that the program was designed involving faculty from diverse fields of expertise.

Dr Balaji Utla opined that the B.Tech. with Minor degree in Electrical Vehicles, though a burning topic, is very broad which includes involvement from ECE/EEE/ME. He suggested introducing a program on ADAS (Advanced Driver Assistance System) technologies/Sensory Technologies.

Dr Krishna Murthy suggested that in the B.Tech. (CSE) minor degree, operating systems and A course on Data base be included. Dr Aruna Kumari, HoD CSE, informed that these are included as open electives. Dr Krishna Murthy suggested checking if these are prerequisites for taking this minor degree.

In case of Minor degree offered by department of IT, Dr Murthy opined that the course should be algorithms with data structures. IT department Head, informed that it is included in the curriculum. Dr Murthy opined that for the Minor degree offered by department of AI, the students should have a strong foundation in Python, Data structures, programming and algorithms. He also said the program should more practice oriented.

He concluded that the content design is good and the curriculum is balanced. He summarized that prerequisites must be specified and the curriculum should be more practice oriented. Dr Krishna Murthy recommended that for an effective teaching learning process, teachers should be trained for these new and emerging courses. He suggested the college collaborate with leading industries for internships so that the faculty may be well equipped for teaching these emerging technologies.

Dr Krishnamurthy suggested MBA department to offer minors in Finance and Business Analytics as these are in demand. He added tie up with industry is a must and the courses should be techno centric with basic tools such as excel.

Dr Balaji Utla added that industry is looking for team players and hence courses should include organisations behaviour, etc. HoD, MBA informed the council that it is proposed to add Business analytics from the year Academic year 2022-2023.

Director appreciated the suggestions given by all the members and stated that the points will be considered in improving the Minor & Honours Courses.

With the above discussions the Council members have ratified the Minor and Honours syllabus offered by various Departments.

Item 7: Placement Statistics for 2018-2022 Batch and the 2019-2023 Batch.

Principal presented the Placement Statistics for the 2018-22 and 2019-23 Batches. The members appreciated the placements and congratulated the students for their success. Dr Krishna Murthy suggested that the placement data be presented in graphical manner for the last three years displaying trend in number of students/companies, quality of companies in view of diversity, etc. He also said IT industry is prone to ups and downs and there may be a steep decline in placements in the IT sector next year. In this regard he suggested that more number of recruiters from across companies including core and software industries be contacted. Principal noted the suggestions and said will implement in the next Academic Council meeting.

The members appreciated the management's initiative. Dr Asha Rani suggested to apply for external grants e.g. DST, AICTE, etc.

Principal informed that we are submitting proposals and responding to the call for proposals from the various government funding agencies. Dr Balaji Utla said being a private college, it's not easy to get funding but he encouraged to submit more proposals.

The Chairman of the Academic Council informed that to encourage the faculty towards research, this initiative has been taken up, as back ground work is also needed to apply for various Projects.
